**AMENDING ORDINANCE NO. 2007-11**  
**BUSINESS LICENSE CODE OF THE**  
**TOWN OF CEDAR BLUFF, ALABAMA**  
**FOR THE YEAR 2007/08 AND EACH SUBSEQUENT YEAR**

**SCHEDULE OF LICENSES AND FEES**

**BE IT ORDAINED BY THE TOWN COUNCIL OF CEDAR BLUFF, ALABAMA**, as follows:

WHEREAS, the Town of Cedar Bluff previously enacted Ordinance No. 2007-11 on November 13, 2007 regulating business license; and

And, WHEREAS, ORDINANCE NO. 2007-11 AMENDED adopted January 14, 2008 is repealed;

And, WHEREAS, the Town of Cedar Bluff Council desires to make certain changes in the regulation of the business license issuance of distribution and alcoholic sales in the Town;

NOW, THEREFORE, BE IT ORDAINED by the Town Council of Cedar Bluff, Alabama, that said Ordinance is hereby amended and certain portions modified, and it is further ordained that the following sections are hereby amended to reflect as follows:
