# c. Ordinance 2015-05 to set Corrections Fund Amount for Municipal Court Cost

The ordinance was read by Town Clerk Susie Surrett as follows:

# ORDINANCE NO. 2015-05

# AN ORDINANCE TO ESTABLISH CORRECTIONS FUND COURT COST

# BE IT ORDAINED by the Town Council of the Town of Cedar Bluff, Alabama, as follows:

**SECTION 1.** In addition to municipal court costs, assessed and collected by the municipal court of the town pursuant to 12-14-14 of the Code of Alabama, 1975 and Ordinance No. 2014-02 of the Town of Cedar Bluff, the town hereby levies and assesses and directs its Municipal Court to collect the following costs,

- (1) For any traffic offense, including driving under the influence, there is hereby assessed an additional forty nine dollars and fifty cents (\$49.50) in court costs, as authorized by section 11-47-7.1 of the Code of Alabama, 1975, which shall be collected by the municipal court of the town and remitted as provided by this section.
- (2) For any misdemeanor offense, there is hereby assessed an additional forty dollars (\$40.00) in court cost, as authorized by section 11-47-7.1 of the Code of Alabama, which shall be collected by the municipal court of the town remitted as provided by this section.
- (3) For violation of any municipal ordinance, the municipal court shall also collect as cost all additional costs and fees by statute of the state for such cases and all such costs and fees shall be remitted as required by said statues.
- (4) All costs collected under subsections (1) and (2) of this section shall be remitted to a special fund designated as the town's corrections fund, which the town clerk is hereby authorized and directed to establish. Funds deposited into the corrections fund shall be used only for the purposes permitted by section 11-47-7.1 of the Code of Alabama, 1975.

#### Ordinance No. 2015-06 Annexation of Property for John Cook

WHEREAS, on the 23<sup>rd</sup> day of January, 2015 John Cook, being the owner of all the real property hereinafter described, did file with the Town Clerk a petition asking that the said tracts or parcels of land be annexed to and become a part of the Town of Cedar Bluff; and

WHEREAS, said petition did contain the signatures of all of the owners of the described territory and a map of said property showing its relationship to the corporate limits of the Town of Cedar Bluff; and

WHEREAS, the governing body did determine that it is in the public interest that said property be annexed to the Town of Cedar Bluff and it did further determine that all legal requirements for annexing said property have been met pursuant to Sections 11-42-20 through 11-42-24, Code of Alabama 1975;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF CEDAR BLUFF, ALABAMA, AS FOLLOWS:

Section 1. The Council of the Town of Cedar Bluff, Alabama, finds and declares as the legislative body of the Town that it is in the best interests of the citizens of the Town, and the citizens of the affected area, to bring the territory described in Section 2 of this ordinance into the Town of Cedar Bluff.

Section 2. The boundary lines of the Town of Cedar Bluff, Alabama, be, and the same are hereby altered or rearranged so as to include all the territory heretobefore encompassed by the

corporate limits of the Town of Cedar Bluff, Alabama, and in addition thereto the following described territory, to-wit:

Lot No. 3 of Block B of McElrath Subdivision as the same appears of record in the Probate Office of Cherokee County, Alabama, in Plat Book 8 at page 78. Said lot of land lying in and being a part of the Northeast Quarter of the Northwest Quarter Section 35, Township 9 South, Range 10 East, in Cherokee County, Alabama.

Section 3. This ordinance shall be published as provided by law, and a certified copy of same, together with a certified copy of the petition of the property owners, shall be filed with the Probate Judge of Cherokee County, Alabama.

Section 4. The territory described in this ordinance shall become part of the corporate limits of Cedar Bluff, Alabama, upon publication of this ordinance as set forth in Section 3, above.

#### Annexation of Property for William and Linda Pinson and Margaret Pinson

WHEREAS, on the 22<sup>nd</sup> day of January, 2015 William C. and Linda Pinson and Margaret Pinson, being the owners of all the real property hereinafter described, did file with the Town Clerk a petition asking that the said tracts or parcels of land be annexed to and become a part of the Town of Cedar Bluff; and

WHEREAS, said petition did contain the signatures of all of the owners of the described territory and a map of said property showing its relationship to the corporate limits of the Town of Cedar Bluff; and

WHEREAS, the governing body did determine that it is in the public interest that said property be annexed to the Town of Cedar Bluff and it did further determine that all legal requirements for annexing said property have been met pursuant to Sections 11-42-20 through 11-42-24, Code of Alabama 1975;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF CEDAR BLUFF, ALABAMA, AS FOLLOWS:

Section 2. The boundary lines of the Town of Cedar Bluff, Alabama, be, and the same are hereby altered or rearranged so as to include all the territory heretobefore encompassed by the

corporate limits of the Town of Cedar Bluff, Alabama, and in addition thereto the following described territory, to-wit:

Lot No. 26 of Wild Acres Subdivision as the same appears of record in the Probate Office of Cherokee County, Alabama, in Plat Book 6 at page 20. Said lot of land lying in and being a part of the Sections 34 and 35, Township 9 South, Range 10 East, in Cherokee County, Alabama.

Lot No. 25 of Wild Acres Subdivision as the same appears of record in the office of the Judge of Probate of Cherokee County, Alabama in Plat Book 6 at page 20, as revised by a revision of a portion of said subdivision as the same appears of record in Plat Book 6 at page 26. Said lot of land lying in and being a part of Sections 34 and 35 in Township 9 South, Range 10 East, in Cherokee County, Alabama.

Section 3. This ordinance shall be published as provided by law, and a certified copy of same, together with a certified copy of the petition of the property owners, shall be filed with the Probate Judge of Cherokee County, Alabama.

# e. Approval of Resolution 2015-02 for Modification of T-Mobile Equipment on Tower located at 4855 Church Street

The resolution was read by Town Clerk Susie Surrett as follows:

#### RESOLUTION NO. 2015-02

WHEREAS, T-MOBILE has requested to modify wireless telecommunication equipment on an existing monopole tower at 4855 Church Street to provide improved wireless services essentially within the corporate limits and police jurisdiction of the Town of Cedar Bluff, AL and;

WHEREAS, T-MOBILE has complied with Town's Ordinance No. 2011-02 and has demonstrated the need for this wireless facility to deliver consistently reliable services in the identified area, and;

WHEREAS, both the Town and T-MOBILE customers in Cedar Bluff, AL will benefit from improved service and;

WHEREAS, the Town's consultant, The Center for Municipal Solutions (CMS), recommends the granting of a Special Use Permit for modification of this facility located at 4855 Church Street, Cedar Bluff, AL, which consist of an existing 194' monopole tower;

THEREFORE, BE IT RESOVED by the Town Council of the Town of Cedar Bluff, AL that T-MOBILE is hereby granted a Special Use Permit to modify an existing facility at 4855 Church Street, Cedar Bluff, AL. As recommended by CMS, the Special Use Permit is subject to compliance with the following conditions prior to the issuance of said permit and/or a Certificate of Completion:

- 1. To prevent warehousing of permits or authorizations and to assure the best service to the Town's residents as expeditiously as possible, the facility must be built, activated and be providing service no later than one hundred twenty (120) days after the issuance of the Special Use Permit or other applicable authorization, subject to commonly accepted *force majeure* exceptions acceptable to the Town. T-MOBILE may petition the Town for an extension of this for good cause shown, but the decision whether or not to grant the extension shall exclusively be the prerogative of the Town.
- 2. T-MOBILE shall provide contractor information to CMS and Town prior to request for issuance of Business License.
- 3. Once T-MOBILE has met all the conditions of the permit and any other requirements of the Town, T-MOBILE must notify the Town's consultant prior to start of construction and for all required inspections.
- 4. At the completion of construction, T-MOBILE must notify the Town's consultant and provide proof that all inspections have been satisfactorily completed and the project is ready for a final on-site inspection. Upon passing the final inspection, a recommendation to issue a Certificate of Occupancy shall be made.
- 5. T-MOBILE shall not be permitted to actually provide service commercially until the Certificate of Occupancy or its functional equivalent is issued or risk forfeiting its Permit.
- 6. The Certificate of Occupancy shall not be issued until all fees and costs associated with this Permit, including inspections, have been paid.

## 7. <u>Citizen Comments: Barbara Wedding- Pothole</u>

Mrs. Wedding asked the Council if there was something that could be done with the condition of her cul-de-sac. She stated it had failed to be patched the last few times the town patched roads in town. The Mayor Tammy Crane told Mrs. Wedding she would look into the problem and seek out a solution. Councilmember Dewayne Agan told Mrs. Wedding the ditches need digging out to take care of the water standing in the road and he would look into the County Highway Department doing it for the town.

## 8. Other Comments

Councilmember Dewayne Agan said he had been made aware of a problem with the concrete floor in the fire department that needs repairing. He stated a couple of prices had been received with the lowest being \$1,800.00. He made the motion to set aside \$1,800.00 to fix the floor when weather permits and when we have a place to put the fire trucks and Councilmember Billie Burkhalter seconded the motion.

At this time Mayor Tammy Crane stated the main computer tower for the Police Department has went down and Mayhall Computers has given an estimate for the tower of \$687.00. Councilmember Dewayne Agan made the motion to purchase the tower from Mayhall Computers for the price given of \$687.00 and Councilmember Norman Burton seconded the motion.

She also stated that she would like to recommend the Town hire the Firm of Turnbach, Warren, Lloyd, Fredrick and Smith of Gadsden to represent the Town as Legal Counsel. Councilmember Dewayne Agan put in the form of a motion to accept the letter of resignation from Bill Hawkins and hire the Firm of Turnbach, Lloyd, Fredrick and Smith as the Town's Legal Counsel and Councilmember Norman Burton seconded the motion.

Mayor Tammy Crane made the recommendation to accept the plat for the Subdivision of Summer Breeze into the Town. Councilmember Norman Burton made the motion to accept the plat with the stipulation of Doyle Buffington maintains the streets in the subdivision for a period of five years and Councilmember Billie Burkhalter seconded the motion.
