### 6. Approval of Earmarking AT&T Funds

Mayor Crane stated that since the lawsuit with the Utility Board was over, the Council needed to earmark the funds the town will receive from AT&T. She said she felt due to the emergency repairs on Horton Street, it would be best to earmark the money received this year into the town's reserve account. Mayor Crane explained to the Council that due to the tile collapsing in the street, emergency repair had to be done at the cost of around \$22,000.00. Councilmember Norman Burton made the motion to put the funds received from AT&T this year into the town's reserve account and let the next Council decide what to do with the funds after this year's. Councilmember Leatha Harp seconded the motion.

#### 7. <u>New Business</u> <u>Paralution 2016 04</u> Back to School Sales

#### a. Resolution 2016-04 – Back to School Sales Tax Holiday

Mayor Crane asked Town Clerk, Susie Surrett to read the resolution:

#### RESOLUTION 2016-04 PROVIDING FOR TOWN OF CEDAR BLUFF PARTICIPATION IN THE "SALES TAX HOLIDAY" AS AUTHORIZED BY ACT NO. 2006-574 IN AUGUST 2016

**WHEREAS**, during its 2007 Regular Session, the Alabama Legislature enacted Act No. 2006-574, effective July 1, 2006, which provides an exemption of the state sales and use tax for certain non-commercial purchases related to school clothing and supplies during the first full weekend in August of each year; and

**WHEREAS**, Act No. 2006-574 authorizes the municipality to provide for an exemption of municipal sales and use taxes for purchases of items covered by the Act during the same time period in which the state sales and use tax exemption is in place, provided a resolution to that effect is adopted at least thirty days prior to 12:01 a.m. on the first Friday in August; and

**WHEREAS**, the TOWN OF CEDAR BLUFF Town Council has affirmatively voted to grant the exemption of municipal sales and use taxes on purchases covered by Act No. 2006-574 during the first full weekend of August 2016, beginning at 12:01 a.m. on Friday, August 5, 2016 and ending at twelve midnight on Sunday, August 7, 2016, the first full weekend of August in 2016; and

**WHEREAS,** <u>Code of Alabama 1975</u>, § 11-51-210(e) requires that the municipality notify the Alabama Department of Revenue of any new local tax or amendment to an existing local tax levy at least 30 days prior to the effective date of the change; and

**WHEREAS,** the exemption of certain municipal sales and use taxes for the first full weekend of August 2016 herein adopted by the municipality is an amendment to the municipality's sales and use tax levy warranting notice to the Alabama Department of Revenue as provided in <u>Code of Alabama 1975</u>, § 11-51-210(e);

**THEREFORE BE IT RESOLVED BY THE TOWN OF CEDAR BLUFF TOWN COUNCIL** that it does hereby provide for an exemption of the municipal sales and use tax on purchases of items covered by Act No. 2006-574 beginning at 12:01 a.m. on Friday, August 5, 2016 and ending at twelve midnight on Sunday, August 7, 2016.

**BE IT FURTHER RESOLVED** that a copy of this resolution be spread upon the minutes of the April 11, 2016 meeting of the TOWN OF CEDAR BLUFF Town Council, and be immediately forwarded to the Alabama Department of Revenue in compliance with <u>Code of Alabama 1975</u>, § 11-51-210(e).

IN WITNESS THEREOF, the TOWN OF CEDAR BLUFF Town Council has

caused this Resolution to be executed in its name and on its behalf by its Mayor on this the  $11^{\text{th}}$  day of April 2016.

Next Mayor Crane stated that she had been contacted by several people regarding having the yard sale in the park monthly. She said the last one had been very successful and would like to see it done each 1<sup>st</sup> Saturday of the month. Councilmember Norman Burton suggested making it permanent for every first Saturday. The Council was in agreement that it would be good for the community.

Mayor Crane gave the Council the dates for the car shows coming up in the park. It will be on the 4<sup>th</sup> Saturday of the month. She also announced something new for Liberty Day this year, a corn hole tournament. She said she had someone handling the tournament. She also announced the fire department would not be selling barbeque this year, due to the high cost of the meat. She said they would instead be selling hamburgers, hot dogs and steak sandwiches.

Next Mayor Crane said she wanted to make the Council aware that the Community Center had some damage due to termites from years ago. She said it was not covered under the town's insurance. Councilmember Norman Burton said he felt it needed to be check over to see what repairs are necessary and get estimates.
