The ordinance is as follows:

ORDINANCE NO. 2017-01

BE IT ORDAINED BY THE TOWN COUNCIL OF CEDAR BLUFF, ALABAMA, AS FOLLOWS:

Section 1. In conformity with the provisions Act No. 2017-120 enacted by the Alabama Legislature during the 2017 Regular Session, providing for a State Sales Tax Holiday, the Town of Cedar Bluff, Alabama, exempts "covered items" from municipal sales and use tax during the same period each year, beginning at 12:01 a.m. on the third Friday in July and ending at twelve midnight the following Sunday,

Section 2. This ordinance shall be subject to all terms, conditions, definitions, time periods, and rules as provided by Act 2017-120.

Section 3. The Town Clerk is hereby authorized and directed to certify a copy of this ordinance under the seal of the Town of Cedar Bluff, Alabama, and to forward said certified copy to the Alabama Department of Revenue to be recorded and posted on the Department website.
