

ORDINANCE NO. 2007-11 AMENDED
BUSINESS LICENSE CODE OF THE
TOWN OF CEDAR BLUFF, ALABAMA
FOR THE YEAR 2007/08 AND EACH SUBSEQUENT YEAR
SCHEDULE OF LICENSES AND FEES

BE IT ORDAINED BY THE TOWN COUNCIL OF CEDAR BLUFF, ALABAMA, as follows:

WHEREAS, the Town of Cedar Bluff previously enacted Ordinance No. 2007-11 on November 13, 2007 regulating business license; and

WHEREAS, the Town Council desires to make certain changes in the regulation of the business license issuance of distribution and alcoholic sales in the Town;
